Savings, Updates, and PD&T

This quarter is highlighted by over \$1 million in total savings by SharelT members, generated through SharelT master agreements. Over this past quarter, SharelT hosted 6 unique webinars and professional development opportunities, drawing in 163 participants. Among these an Ethical Hacker Course, courtesy of BCNET, which saved members ~\$6,000.

Cybera has negotiated a new Campus and School Azure-only Agreement for the SharelT members to leverage. This agreement is customized for education consumers with a low initial commitment of \$1600 and pay as you go from there. In addition, data egress fees can be waived up to 15%. Cybera will be scheduling a kick-off session near the end of February for this new agreement and sending a communications to all SharelT members with information on how to leverage this agreement,
