ShareIT starts the fiscal year off with a bang, posting our highest estimated savings in a quarter by a factor of two, at just under \$8.5 million! We are incredibly happy to provide this level of savings to our members. We are also pleased to announce that our work has strengthened connections between tech leaders and experts within Alberta's schools and post-secondary institutions. Current Procurements in Flight

Networking Hardware v2



Status: **Contracting**

Anticipated Award: **Mid August 2022**

The Networking Hardware NRFP is currently in the contracting stage. The scope will include the following categories:

- Edge Switches
- Core Switches: small, medium and large
- Data Center Switches
- Edge Routers
- Wireless LAN Controllers
- Wireless Access Points

End User Computing Hardware v2



Status: **Awarded**

Through a detailed NRFP process, Cybera has entered into a three year contract with both Microserve and WBM for the supply of end user hardware and services - both are effective as of Aug. 4, 2022.

This was ShareIT's largest project to date with 26 participating members, and an expansion on the scope from the previous end user computing hardware agreements.

With 26 participating members, including 10 K-12 school boards, we are moving forward to establish services in the following categories: Cybersecurity, IT Project Management, Networking, Development & Operations, Infrastructure & IT Auditing.

End Point Detection Response / Managed Detection Response



Status: **Service Development**

Anticipated Award: **Fall 2022**

Endpoint Detection and Response (EDR), Extended Detection and Response (XDR) and Managed Detection and Response (MDR) are three emerging endpoint security technologies built to provide greater visibility, threat detection and response across all endpoints.

Approved as a ShareIT procurement initiative by the Oversight Committee on June 2, 2022, this procurement is currently in the Service Development phase.
